ARTICLES OF INCORPORATION OF 95 JUL 11 PH 4: 23 TURNBULL BAY DEVELOPMENT, INCERCRETAL ALIESTS AND ARTICLES OF INCORPORATION

I, the undersigned, hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE 1

The name of this corporation shall be:

TURNBULL BAY DEVELOPMENT, INC.

ARTICLE II

This corporation may engage in any activity of business permitted under the laws of the Un.ted States and permitted under the laws of the State of Florida:

- A. To provide all aspects of land acquisition, development and construction which may be necessary, advantageous or proper in the conduct of the said business or businesses.
- B. To exercise generally such powers as may be incident to or convenient for the purpose and business of the Corporation and to have, exercise, and enjoy all the rights and privileges of Corporation for profit under the laws of the State of Florida.
