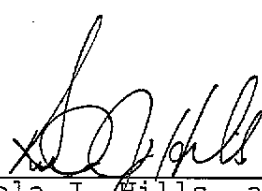
SECOND: The date of the amendment's adoption: May 21<sup>st</sup>, 2002.
