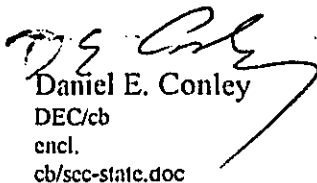

ARTICLES OF INCORPORATION  
OF  
LANGTON, ZELNO, HUGHES & ASSOCIATES, INC.

ARTICLE I

The name of the corporation is LANGTON, ZELNO, HUGHES & ASSOCIATES, INC.

ARTICLE II

The corporate existence shall commence on July 6, 1995 and the duration of the corporation shall be perpetual.

ARTICLE III

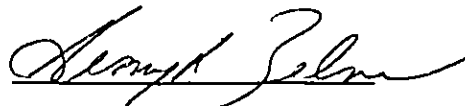

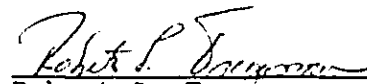
