ARTICLE I. Name

The name of the corporation is D & G Woodcrafting, Inc.

ARTICLE II. Duration

This corporation is to exist perpetually unless sooner dissolved according to law.

ARTICLE III. Purpose

The purpose of the business to be transacted by this corporation shall be all other acts permitted by law to corporations.

ARTICLE IV. Stock

This corporation is authorized to issue ten thousand shares of one (\$1.00) dollar par value common stock.

The consideration to be paid for each share shall be fixed by the Board of Directors, and may take the form of services rendered, cash, property, or any other form deemed satisfactory by the Board of Directors.

ARTICLE V. Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI. Initial Registered Office & Agent

The street address of the initial registered office of this corporation is 14405 Jim Hunt Road, Clermont, Florida 34711 and the name of the initial registered agent of this corporation at that address is Gary T. Butler.

ARTICLE VII. Initial Board of Directors

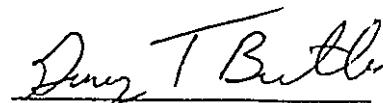
ARTICLE IX. Indemnification

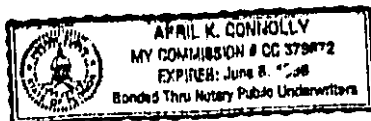
