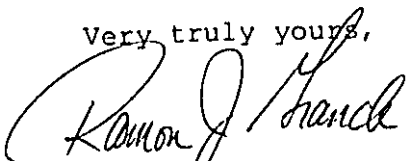

ARTICLE I

The name of the corporation is **CONCRETE ETC., INC.** The principal address of the corporation is: 622 Eagle Drive, Delray Beach, FL 33444.

The aggregate number of shares of stock which the corporation shall have authority to issue is one hundred (100) at \$1.00 par value.

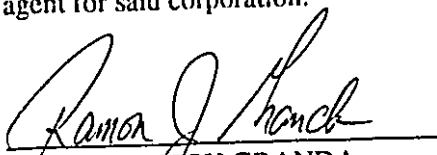
ARTICLE V

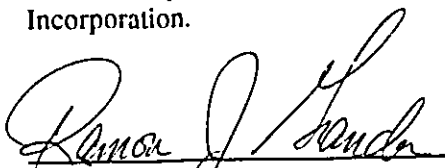
