

ARTICLES OF INCORPORATION

OF

SALVATORE BOCHICCHIO, C.P.A., P.A.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation of such corporation.

ARTICLE ONE

The name of the Corporation is SALVATORE BOCHICCHIO, C.P.A., P.A. (hereinafter the "Corporation").

ARTICLE TWO

The general nature of this business to be transacted is:

(a) certified public accounting; and

(b) To engage in any other lawful business or businesses and to exercise and enjoy all the rights, powers and privileges incident to corporations for profit, organized and existing by virtue of the laws and Constitution of the State of Florida.

ARTICLE THREE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a nominal or par value of one dollar (\$1.00) per share.

All stock, when issued, shall be fully paid, and nonassessable. The entire capital stock, or any portion thereof, may be paid for in cash, property, labor or services, for a consideration having a value in the judgment of the Board of Directors of the corporation, at least equivalent to the full value of the stock issued.

ARTICLE FOUR

The term of existence of this corporation is perpetual.

ARTICLE FIVE

The number of initial directors of the Board of Directors of the Corporation is one (1). The number of directors may be increased or decreased from time to time by By-Laws adopted by the stockholders, but shall never be less than one (1).

ARTICLE NINE

ARTICLE TEN

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at the stockholders' meeting by a majority of the stockholders entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement expressing their desire that a certain change be made in these Articles of Incorporation.
