The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation of such corporation.

## ARTICLE ONE

The name of the Corporation is SALVATORE BOCHICCHIO, C.P.A., P.A. (hereinafter the "Corporation").

## ARTICLE TWO

The general nature of this business to be transacted is:

- (a) certified public accounting; and
- (b) To engage in any other lawful business or businesses and to exercise and enjoy all the rights, powers and privileges incident to corporations for profit, organized and existing by virtue of the laws and Constitution of the State of Florida.
