

<u>ARTICLES OF INCORPORATION</u> <u>OF</u> <u>CAR WORLD & TRUCK CENTER, INC.</u>



The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE: NAME

The name of the Corporation is CAR WORLD & TRUCK CENTER, INC. The principal address is 8315 Congress Street, Port Richey, FL 34668.

ARTICLE TWO: TERM OF EXISTENCE

The duration of the Corporation is perpetual. Corporate existence is to commence on the date of filing of the Articles of Incorporation by the Secretary of State.
