The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE - NAME

The name of the corporation is 11th St.U.S.A.INC.

ARTICLE TWO -PRINCIPLE OFFICE

ARTICLE THREE - CAPITAL STOCK
