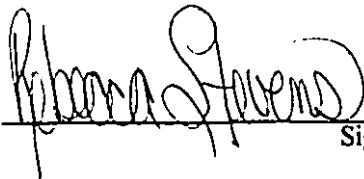
PURPOSES OF THE CORPORATION
