ARTICLE ONE: NAME

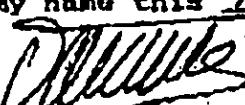

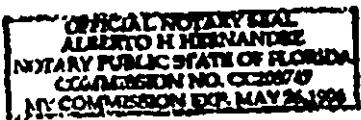
