ARTICLES OF INCORPORATION

OF

COOL RUNNINGS PRODUCTION, INC.

The undersigned subscribers of the Articles of Incorporation, natural persons competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

COOL RUNNINGS PRODUCTION, INC.

ARTICLE II. NATURE OF BUSINESS

The Corporation is a corporation for profit and is organized for the following purposes:

- (A). To engage in any lawful business or activity for which the corporation is organized pursuant to the provisions of the Florida Business Corporation Code and as above provided.
- (B). To make gifts of its property or cash either to charitable organizations or otherwise, when deemed in the interest of the corporation. To also adopt such pension profit sharing, stock option and deferred compensation plans for officers, employees and directors and to grant such stock options to officers, employees, directors, and others as the Board of Directors may deem to be in the best interest of the corporation.
- (C). - (D). To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of

pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required.

- (E). To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- (F). To endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise dispose of the shares of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers, and privileges of ownership, including the right to vote such stock.
- (G). To become guarantor or surety for any person, firm or corporation for any purpose of transaction whatsoever.

These provisions shall not be construed to invalidate any contract or other transaction which would otherwise be valid under the common laws and statutory law applicable thereto.
