ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- MAI CORPORATION OF TAMPA, FLORIDA  
and whose principal office location is 6202 40TH STREET NORTH  
TAMPA, FL 33610

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

CONVENIENCE STORE and shall include the

transaction of any and all lawful business for which corporations may be  
incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock, having
