Enclosed is the Annual Report of Absolutely Fabulous of South Florida, Inc., with payment, it is being filed late. I am requesting a waiver of penalty due to exterminating circumstances.

In February I asked all my clients to file their annual report as soon as possible because of the new "Killer" penalty. I specifically remember asking Absolutely Fabulous and getting the response "I just did that a little while ago."
