All assets and remaining property of Planet Earth Communications, Inc., have been distributed among its shareholders in accordance with their respective rights and interests.

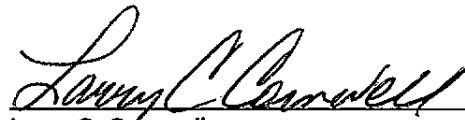
ARTICLE VI
