The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter referred to as the "Corporation") is Goldman Hosford Group Inc.

SECOND: The street address, wherever located, of the principal office of the Corporation is 2661 Noble Drive, Tallahassee, Florida 32312.
