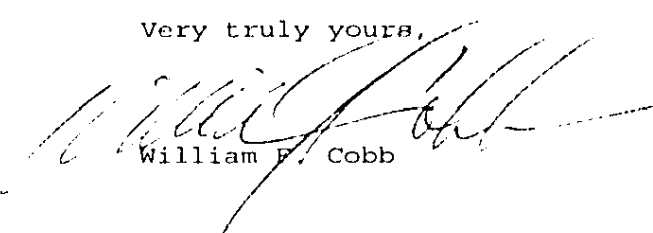

ARTICLES OF INCORPORATION  
OF  
FORT PIERCE SPORTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be FORT PIERCE SPORTS, INC.

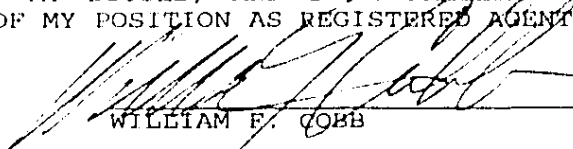

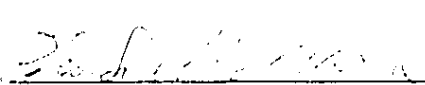
