ARTICLE I

NAME

The name of the corporation shall be EXPANSIVE ENTERPRISES, INC.

ARTICLE II

NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United State and the State of Florida.

ARTICLE III

TERMS OF EXISTENCE

This Corporation is to exist perpetually

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten thousand (10,000) at \$1.00 per share par value, all of which shall be common stock.

ARTICLE V

INITIAL CAPITAL

The amount of capital with which this Corporation will begin business is not less than \$1,000.00. 
