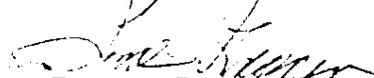

ARTICLES OF INCORPORATION
OF
e-publishing.http, inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is e-publishing.http, inc., and the principal office and mailing address of the Corporation is 920 Tulip Court, Suite 100, Marco Island, Florida 33937.

ARTICLE II - DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III - PURPOSE

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act, including all necessary and relevant business activities and transactions for electronic publishing.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 100,000 shares of common stock.

ARTICLE V - PREEMPTIVE RIGHTS

The holders of the common stock of this Corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, those shares of common stock of this Corporation which may be issued from time to time for money, property or past services, in addition to that stock

authorized and issued by the Corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

ARTICLE VI - REGISTERED OFFICE AND AGENT

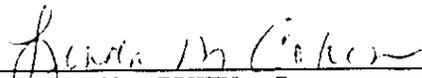
