The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

### **ARTICLE II - NATURE OF BUSINESS**

#### INSTRUCTIONS FOR FILING FICTITIOUS NAME

Intent to use a fictitious name must be published in a designated newspaper at least once a week for four (4) consecutive weeks before the patitioner is allowed to register with the Clerk of the Circuit Court.

Registration consists of the tiling with the clerk of an affidavit signed by all interested persons, statug under oath the names of all those interested and the extent of the interest of each, and the fictitious name under which they wish to do business. This registration is filed after proof of publication has come back from the newspaper.
