Lester E. Sells and Sharon M. Sells, the undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Sharp Shooters Leasing, Inc.

ARTICLE II

The corporation is authorized to and may engage in any activity or business which is lawful in the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one thousand (1000) shares of common capital stock, each share having a par value of \$.01 (one cent). 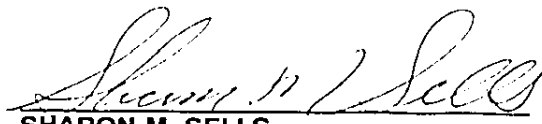
sign a written agreement manifesting their intention to effect a certain amendment of those Articles of Incorporation.

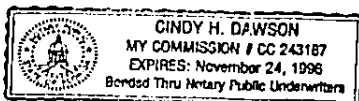

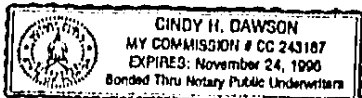
