ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this Corporation is: PHOENIX ENGINEERING, INC.

Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anywise interested.


