The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

1.

#### ARTICLE\_ONE NAME

The name of the corporation is PALM COAST LANDOWNERS ASSOCI-

## ARTICLE\_TWO DURATION

The term of existence of the corporation is perpetual.

### ARTICLE\_THREE PURPOSE

The purpose for which the corporation is organized is to publish a newsletter for absentee landowner's for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

# ARTICLE FOUR CAPITAL STOCK
