ARTICLES OF INCORPORATION
OF

ARTICLE ONE - NAME

The name of the corporation is AMERICAN OFFICE EQUIPMENT OF TALLAHASSEE, INC.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.


ARTICLE NINE - BY-LAWS


