ARTICLE OF INCORPORATION  
OF

AAA DISCOUNT LONG DISTANCE, INC.

ARTICLE I - NAME

The name of the corporation is: AAA DISCOUNT LONG DISTANCE, INC.

ARTICLE II - PURPOSE OF BUSINESS

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State of Florida and in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE III-CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$1.00 per share. All stock issued shall be fully paid and nonaccessible.

ARTICLE IV- TERM OF EXISTENCE

This corporation is to exist perpetually.

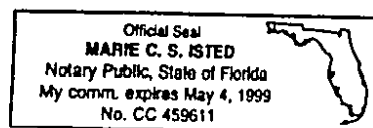
