WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation for such corporation:

FIRST:	The name of the corporation in Just The Right Touch
	Cleaning and Personal Services, Inc.

SECOND: The period of its duration is Perpotual.

THIRD: The purpose(s) for which the corporation is organized are to provide full-service cleaning services for residential and commercial properties, new construction clean-up, periodic cleanings, and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

FOURTH: The aggregate number of shares which the corporation shall have authority to Issue is 10,000 shares of common stock having no par value or amount of par value each.
