OF

ARTICLE I

NAME

The name of this corporation is ACTION SEWER & SEPTIC,  
INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence, commencing  
on the date of the filing of these Articles with the  
Department of State.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of  
transacting any or all lawful business for which corporation  
may be incorporated under Chapter 607, Florida Statutes, as  
now exists or may after be amended.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 500 shares of  
One Dollar (\$1.00) par value common stock which shall be  
designated as "Common Shares."

## ARTICLE V

### PREEMPTIVE RIGHTS

Every shareholder upon sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof, as nearly as may be done without issuance of fractional shares, at the price at which it is offered to others.

## ARTICLE VI

### INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered principal office of the corporation is 607 S.W. St. Lucie Crecent, Stuart, Florida 34994, and the name of the initial registered agent of this corporation is John J. Stier.

## ARTICLE VII

### INITIAL BOARD OF DIRECTORS

This corporation shall have one director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the By-laws. However, there shall never be less than one director or more than five. The names and addresses of the initial Board of Directors of this corporation are:

ARTICLE VIII

INCORPORATOR

ARTICLE IX

INDEMNIFICATION

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE X

AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, by a majority vote of the shareholders.

ARTICLE XI

STOCK TRANSFERS--CORPORATION'S RIGHT OF FIRST REFUSAL

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any of the shares of the corporation without first offering such shares of purchase to the corporation at the net asset value thereof. Such offer shall be in writing, signed by the shareholders; shall be sent by registered or certified mail

to the corporation at its principal place of business; and shall remain open for acceptance by the corporation for a period of 90 days from the date of mailing. If the corporation fails or refuses within such 90 day period to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of his/her shares as he/she may deem fit. The president of the corporation is authorized to make any such purchase under this provision.

Each share Certificate issued by the corporation shall have printed or stamped thereon the following legend: "These shares are held subject to certain transfer restrictions imposed by the Articles of Incorporation of the corporation. A copy of such articles is on file at the principal office of the corporation."

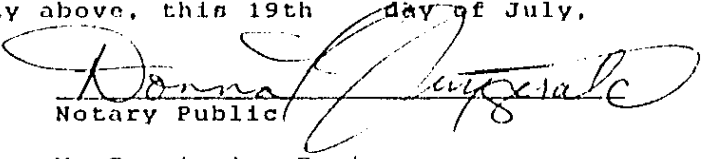
