### **ARTICLE 1 - NAME**

The name of the Corporation is **RG FINE FOODS**, **INC.**, (hereinafter, "Corporation").

## **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE 7 - CORPORATE CAPITALIZATION
