ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation of <u>Intermediary</u> <u>Consultants Group. Inc.</u>, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is <u>Intermediary Consultants Group, Inc.</u>

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be to not as consultants and advisors in business dealings with various entities including but not limited to troubled company financial and debt restructuring, private placement offerings, investment counseling, and general business advise in the United States of America as well as abroad.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of and to invest in, trade in and deal in and with goods, wares, merchandize, real and personal property and services of every class, kind and description.
