# ARTICLES OF INCORPORATION **O**F

# ASIAN MANAGEMENT COMPANY, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### **ARTICLE 1 - NAME**

The name of this corporation is Asian Management Company, Inc.

#### **ARTICLE II - PURPOSE**
