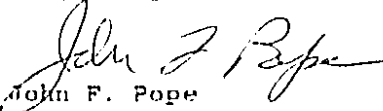

OF

YOU AND ME, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation shall be You and Me, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation is retail sales of food and beverage in all or any of the general powers given private corporations for profit under the laws of the State of Florida.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description.

To engage in any and all other business purposes not prohibited by the laws of the State of Florida.

ARTICLE III

The maximum numbers of shares of stock that this corporation is authorized to have outstanding at any one time shall be 500 shares of common stock having a par value of \$1.00 each.

ARTICLE IV

The amount of capital with which this corporation will begin business is not less than \$500.00.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VI

The address of the initial registered office and the principal address of this corporation is 5609 78th Avenue East, Palmetto, Florida 34221 and the name of the initial registered agent is Robert J. Grieco. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE VII

This corporation shall have three (3) directors, initially. The number of directors may be increased or diminished from time to time, by by-laws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VIII

The name and address of the members of the first Board of Directors is Robert J. Grieco, 5609 78th Avenue East, Palmetto, Florida 34221, Andy Karas, 3920 52nd Drive West, Bradenton, Florida 34210 and Michael Koutsoudis, 3920 52nd Drive West, Bradenton, Florida 34210.

ARTICLE IX

The name and street address of the subscriber of these Articles of Incorporation is Robert J. Grieco, 5609 78th Avenue East, Palmetto, Florida 34221.

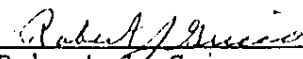
ARTICLE X

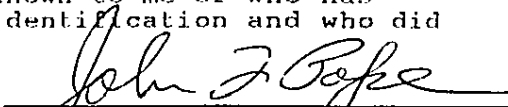
