AUTHOR TELEFORM

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is Wattling Homes, Inc.
- 2. TERM. This corporation shall exist perpetually.
