ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "Texcrete, Inc.". The principal location of the corporation is 200 S. Grandview Avenue, Daytona Beach, Florida 32118.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of importing, purchasing and manufacturing materials and supplying to the building trade at the wholesale and retail level and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

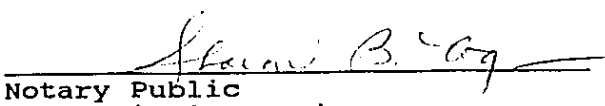

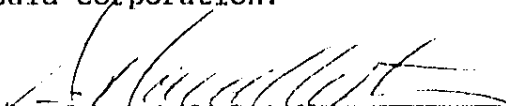

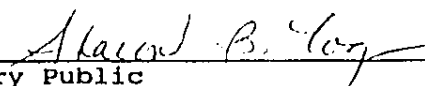
