ARTICLES OF INCORPORATION

OF

The undersigned subscriber(s) to these marketicles of Incorporation, cach a natural person competent to contract, do hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: Thomas H. Greene, Jr., P.A.

ARTICLE II. NATURE OF BUSINESS

The general nature of the corporation is: Law firm.

Any activity or business permitted under the laws of the State of Florida and the United States of America, including, but not limited to the following:
