#### ARTICLES OF INCORPORATION

## ARTICLE I. CORPORATE NAME.

The name of this corporation is PUBLIC RELATIONS INTERNATIONAL, INC. and the principal place of business and mailing address of this corporation is 28100 U.S. 19 North, Suite 502, Clearwater, Florida 34621.

# ARTICLE II. DURATION.

This corporation shall exist perpetually.

#### ARTICLE III. PURPOSE.

This corporation is organized for the following purposes: the general purpose for which this corporation shall be organized shall include the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
