The name of the corporation shall be JAMAICA CONNECTION, INC.

## ARTICLE II. PRINCIPAL OFFICE

Thereafter, every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a shareholder's meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.
