**ARTICLES OF INCORPORATION**  
**OF**  
**QUE MANAGEMENT CORP.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE I  
NAME and PRINCIPAL OFFICE

The name of this corporation shall be QUE MANAGEMENT CORP., and the principal place of business and mailing address of this corporation shall be: 2036 Woodlake Circle, Deerfield Beach, Florida 33442.

ARTICLE II  
TERM OF CORPORATE EXISTENCE

The Corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III  
PURPOSE

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE IV  
CAPITALIZATION

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, every shareholder of this corporation shall have the preemptive right to purchase his pro rata share thereof at the price which it is offered to others, whether or not in excess or par. Fractional shares need not be issued on account of this provision.

ARTICLE V  
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be at 2036 Woodlake Circle, Deerfield Beach, Florida 33442, with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Bernice Queally.

ARTICLE VI  
INCORPORATOR
