The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is:

SENTERS & EVANS, INC., GENERAL CONTRACTORS

ARTICLE II - CORPORATE ADDRESS

The principal address of the corporation shall be 1830 Deanna Drive, Apopka, Florida.

ARTICLE III - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE IV - PURPOSE

The corporation is organized for the purpose of building residential or commercial properties of all kinds, remodeling same and to engage in all other activities or business permitted under the laws of the United States and the State of Florida.


