ARTICLES OF INCORPORATION
OF
FALASCA'S SERVICES INCORPORATED

The undersigned subscriber of these ARTICLES OF INCORPORATION, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I - Name

The name of this corporation is FALASCA'S SERVICES INCORPORATED.

Article II - Duration

This corporation shall exist perpetually, commencing upon filing.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Address

The principal place of business and the mailing address of this corporation is:

Article V - Capital Stock

The number of shares of stock that this corporation is

authorized to have outstanding at any one time is 10,000 shares of common stock with a par value of \$0.10 per share.

Article VI - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof, at the price at which it is offered to others.

Article VII - Initial Registered Office and Agent

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation.

Article XIII - Restriction on Transferability of Stock

The price and terms of which, and the time within which such shares may be offered and sold, shall be further specified in the By-Laws of this corporation.

Article XIV - Affiliated Transactions

This corporation elects to opt out of Florida Statute

607.0901, the affiliated transaction statute. The provisions of Florida Statute 607.0901 will not apply to this corporation.

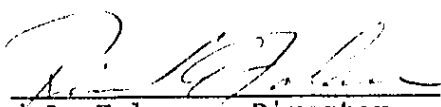

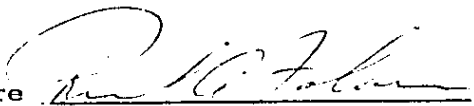
