ARTICLES OF INCORPORATION OF
PREP CONSTRUCTION, INC.

ARTICLE I - NAME

The name of this corporation shall be PREP CONSTRUCTION, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence. It may, however, be sooner dissolved in any manner permitted by law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in construction services and all phases thereof which are necessary, proper, advisable and convenient for the accomplishment of said purpose; and, further, to engage in any other activity or business permitted under the laws of the United States and the State of Florida.

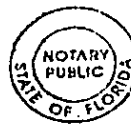


