The undersigned subscriber to these Articles of Incorporation, a natural person competent to centract, does hereby sign and direct these Articles to be delivered to the Department of State, State of Florida, for the purpose of forming a corporation under the laws of the State of Florida.

Article 1 - Name and Mailing Address

This corporation shall exist perpotually.

Article 3 - Purposes
