### ARTICLES OF INCORPORATION

OF

### GENERATIONS III, INC.

WE, THE UNDERSIGNED do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

### ARTICLE I . NAME

The name of the Comporation shall be:

GENERATIONS III, INC., a Florida Corporation

### ARTICLE II -- PURPOSE

- A. To carry on and engage in the business of the manufacture, acquisition, sale, purchase, repair and remodeling of all types of ladies wearing apparel including all accessories thereto and all other matters that may be incidental and related thereto.
