

# ARTICLES OF INCORPORATION OF JUL 21 71 9: 10

CRCC, Inc., n Florida Corroration

The undersigned incorporator, for the purpose of forming a corporation pursuant to the laws of the State of Florida, Florida Statutes, Compter 607, hereby adopts the following Articles of Incorporation:

#### ARTICLE L- NAME

The name of the Corporation is CRCC, Inc., a Florida corporation.

## ARTICI, E II - ADDRESS

The initial mailing address of the Corporation is 3564 N.E. 31st Avenue, Lighthouse Point, Florida 33064.

#### ARTICLE III - PURPOSE

The purposes for which the Corporation is organized is to transact any or all lawful business for which corporations may be organized under Florida Statutes, Section 607.

## ARTICLE IV - CAPITAL STOCK
