ARTICLE OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Plorida General Corporation Act, do herby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is ANI - USA, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized are:

1.- To engage in the business of IHPORT/EXPORT-WHOLESALE.
