ARTICLE I. CORPORATE NAME

The name of this Corporation is: KANCO, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

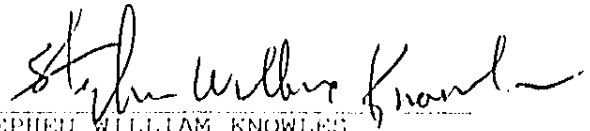

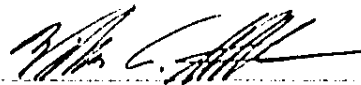
ARTICLE IX. AMENDMENT

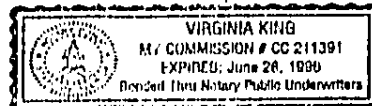
