ARTICLES OF INCORPORATION

OF.

SOPHIE'S, INC.

ARTICLE I

The name of this corporation is **Sophie's**, **Inc.** The principal office of the corporation shall be located at 117 Beverly Parkway, Pensacola, Florida 32505, but meetings of members and directors may be held at such place within the State of Florida, County of Escambia, as may be designated by the Board of Directors.

ARTICLE II

This corporation shall have perpetual existence.

The effective date of the corporation shall be as of the filing with the Secretary of State and the acceptance by the Secretary.


