The undersigned Incorporator for the purpose of forming a corporation under Chapter 607 Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is INTEGRATED CLAIM STRATEGIES, INC. The business mailing address of the corporation is 4840 Flamingo Road, Tampa, Florida 33611-1012.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE IV - PURPOSE


