The undersigned incorporator hereby adopts these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

**I
NAME**

The name of this corporation shall be GRYPHUS BOATWORKS, INC.

**II
PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office and mailing address of this corporation shall be 1390 Main Street, Sarasota, FL 34236.

**III
PURPOSES**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto.

**IV
CAPITAL STOCK**

There shall be a single class of common stock with a par value of \$.10 (ten cents) per share, with no restrictions as to the holder's voting privileges or rights to distributions, except as provided by law. The aggregate number of shares of common stock authorized to be issued by this corporation shall be 100,000 shares.

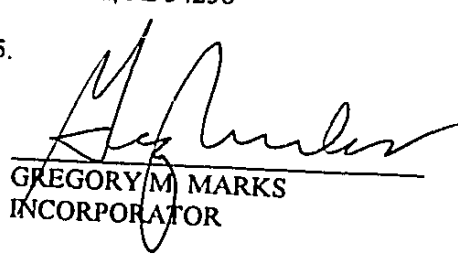

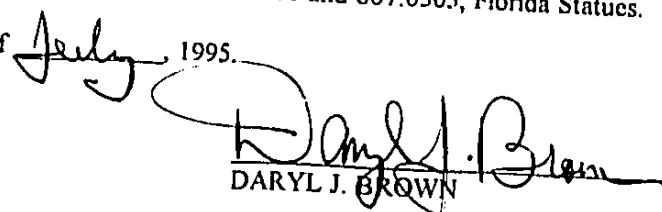
