We, the undersigned, as proper persons acting as
incorporators of a corporation under the laws of the State of Florida
Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is Finish Line Coating, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose of the corporation is to distribute automotive products and such other activities as may from time to time be specifically found by the Board of Directors to be suitable.

FOURTH

The aggregate number of authorized shares is 1000.

FIFTH

The corporation will not commence business until at least 100 dollars have been received by it as consideration for the issuance of shares.

SIXTH

Cumulative voting of shares of stock are not authorized.

Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are hereby elected. Therefore the corporation need not offer to sell a pro rata proportion of its stock to its shareholders before selling any additional shares.

The Board of Directors may exercise all such powers and do all such acts as may be exercised or done by the Corporation or as are appropriate to the management of the business and the conduct of the affairs of the Corporation, subject, nevertheless, to the provisions of the laws of the State of Florida, of these Articles of Incorporation, and of the Bylaws of the Corporation.

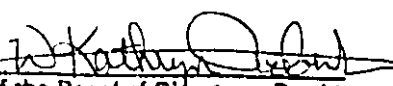
