ARTICLES OF INCORPORATION OF

ATLANTIC SOUTHERN YELLOW PINE, INC.

ARTICLE 1:

The name of this corporation shall be:

ATLANTIC SOUTHERN YELLOW PINE, INC.

ARTICLE II

This corporation is to exist perpetually and is to commence existence upon filing.

ARTICLE III

The mailing address and initial street address of the principal office of the corporation in the State of Florida is 250 Catalonia Avenue, Suite 403, Coral Gables, Florida, 33134. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE IV

The maximum number of shares the corporation is authorized to have outstanding at any one time is 300 shares of common stock having a par value of \$1.00 per share.

ARTICLE V

The Initial Registered Office of the corporation shall be 250 Catalonia Avenue, Suite 403, Coral Gables, Florida, 33134; the Initial Registered Agent of the corporation whose business office is at such address is Justo Pinero.

ARTICLE VI

The business of the corporation shall be managed by its Board of Directors. The number of directors constituting the Board shall be subject to a minimum of 1 (one) and such minimum may be increased from time to time by amendment of the bylaws in a manner not prohibited by law.

ARTICLE VII

This Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed to them by the shareholders, and approved at a shareholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation shall be made. All rights of shareholders are subject to this reservation.

ARTICLE VIII
